## 6. IOS & Android App Permissions and Data Collection

The app manages the app and uses and requests the following:

- x **Analytics (Google)**  
The app embeds the Google Analytics SDK, which may collect some information. See Point 2 to see how we collect data \*

- Push notifications**  
The app can receive notifications and uses a unique and anonymous identifier (UID) provided by Apple (APNS) or Google (GCM) to receive the notification.
- x **Permission**  
The app can use the CAMERA permission to scan QRCode (no data sent over the network).  
The Early Careers Ltd app can use the LOCATION permission to work with the maps.

You have the right at any time to delete The Early Careers Ltd app terminated all the above permissions and tracking, effective immediately.

## 7. What are your data protection rights?

Early Careers Ltd would like to ensure you fully know your data protection rights. Every user is entitled to the following:

- x **The right to access**  
You have the right to request or copies of your data. We may charge you a small fee for this service.
- x **The right to rectification**  
You have the right to request that corrects any information you believe is inaccurate. You also have the right to request to complete information you believe is incomplete.
- x **The right to erasure**  
You have the right to request that erases your data under certain conditions.
- x **The right to restrict processing**  
You have the right to request that restricts the processing of your data under certain conditions.
- x **The right to object to processing**  
You have the right to object to EarlyCareers.Scot's processing of your data under certain conditions.
- x **The right to data portability**  
You have the right to request that transfers the data we have collected to another organisation or directly to you under certain conditions.

## 8. What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

## 10. What types of cookies do we use?

There are several different types of cookies. However, our website uses:

- **Functionality**  
EarlyCareers.Scot uses these cookies so that we recognise you on our website and remember your previously selected preferences. These could include what language you prefer and the location you are in. A mix of first-party and third-party cookies is used.
- **Advertising**  
EarlyCareers.Scot uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and IP address. Early Careers Ltd sometimes shares limited aspects of this data with third parties for advertising purposes. We may also share anonymous online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## 11. How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, some of our website features may not function in a few cases.
